## ORDER:

In the reference  $1^{\rm st}$  read above, Ministry of Home Affairs, Government of India, New Delhi have permitted reopening of cinemas / theatres / multiplexes with upto 50% of their seating capacity, in areas outside the containment zones only, for which Standard Operating Protocol shall be issued by the Government.

- 2. In the reference 2<sup>nd</sup> read above, it was provided that separate orders regarding date of opening will be issued for cinemas / theatres / multiplexes, entertainment parks and similar places.
- 3. After careful consideration of the matter, it is hereby decided to permit cinemas / theatres / multiplexes to reopen with upto 50% of their seating capacity in areas outside the containment zones only, with immediate effect.
- 4. The management of cinemas / theatres / multiplexes shall ensure that:
  - (i) All persons, audience, staff, vendors etc., use masks at all times;
  - (ii) Hand sanitizers are available at entry / exit points and common areas;
  - (iii) Physical distancing and crowd management measures are followed;
  - (iv) Sanitization of entire premises particularly common areas shall be done after every screening;
  - (v) Temperature setting of all air conditioning devices should be in the range of 24-30° Celsius. Relative humidity should be in the range of 40-70%. Re-circulation of air should be avoided and intake of fresh air should be as much as possible.
  - (vi) Show timings should be staggered to ensure that intervals of different shows do not occur simultaneously
